Motion carried unanimously.

**Item #2** Ordinance No. 2019-03-19 Amend Ordinance No. 2015-05-19 for Late Fee. – Dick Hoffman stated this late fee is for businesses that do not pay business permit fee by 12/31, it drags on and on, late fee is \$50. Dick Hoffman made a motion to adopt Ordinance 2019-03-19 as written, seconded by Vince Babb. Motion carried unanimously.

**Item #3** Safety at Impound Lot – Vince Babb stated he was still working on getting all the info together on new equipment for the Impound yard security. Dick Hoffman made a motion to table this until the next meeting, seconded by Dutch Antonisse. Motion carried unanimously.

## New Business

**Item #1** Road Work – Michael Juica stated we have patched holes on Leisure Land two different times this past month and the rain just washes it out, the new Steel Roller and the Chevy truck are up and running, the International truck is here in the Parking Lot, street crew is in need of cones and flags for when they are working on the road. Dick Hoffman made a motion to spend up to \$2000 on cones and flags for the street crew, seconded by Vince Babb. Motion carried three for and Michael Juica abstained.

Michael Juica stated he also needs a contract between the city and himself on leasing the (3) of his trailers, so the trailers can have exempt tags, no money is exchanged, the city pays for upkeep and tags. Dick Hoffman made a motion to have a contract between the City of Payne Springs and Michael Juica for lease of three trailers, no money exchanged, City pays up keep and buys tags for trailers, seconded by Vince Babb. Motion carried three for and Michael Juica abstained.
