March 17, 2020**

Mayor Pro-Tem Vincent Babb called the meeting to order at 6:30 PM.

Mayor Pro-Tem Vincent Babb invited everyone to stand for the Pledge of Allegiance, led by Mayor Pro-Tem Vincent Babb.

Mayor Pro-Tem Vincent Babb did call roll, Cody Barnett, Dutch Antonisse were present, Andrea Miller and Michael Juica were absent. Mayor Pro-Tem Vincent Babb stated he reserves his rite to make motions and vote. Quorum was established.

Cody Barnett made a motion to accept the Regular Meeting Minutes of 2/18/20 as written, seconded by Dutch Antonisse. Motion carried unanimously.

Treasurer's report given by Dutch Antonisse. Dutch Antonisse covered the P&L, Balance Sheet, and Impound Lot for the month of February, Dutch Antonisse stated we are on budget as of now. Old Business

Item #1 Cyber Training – Mayor Pro-Tem Vincent Babb stated TML has sent a link for those who operate the computers in the City, No action taken at this time.

Dutch Antonisse stated he was very disappointed in the other Council Members and the Police Department that were not present for the meeting.

Item #2 Scott Tuley Presentation – Scott Tuley stated how Precinct 2 could help the small cities in Henderson County, they helped Eustace last year on the road and saved them \$27,000, they are in the process of helping Enchanted Oaks with the roads and is saving them little over \$175,000. **Michael Juica joined the meeting at 6:57.** Scott Tuley gave a PowerPoint presentation on the equipment that they have to help the small cities, stated they haven't done

any Oil & Sand this year but have been cleaning ditches and fixing culverts. **Chief Meadows joined the meeting.**

New Business

Item #1 Business Permit Bran-Co Supply – Steve Higgins stated he would like to put a Plumbing Supply Area in the Cedar Creek Power Sports & Guns building. Cody Barnett made a motion to give Bran-Co Supply a business permit, seconded by Michael Juica. Motion carried unanimously.

Item #2 Business Permit Cedar Creek Power Sports & Guns (Previous Cedar Creek Water Sports) - Steve Higgins stated he has bought Cedar Creek Power Sports and would like to amend the business permit to have his name as owner on business permit. Cody Barnett made a motion to change owners on business permit, seconded by Michael Juica. Motion carried unanimously.

Item #3 Computer Need & Update – Karen Juica stated you have two estimates in your folder, the first one is just getting Chief’s new computer up and running, the backup power box and L3 software on it, the second one is all that and, plus switching over the City emails. Dutch Antonisse made a motion to go with page 2 of the estimates, seconded by Cody Barnett. Motion carried unanimously.

Item #4 Impound Lot – Karen Juica stated there is a print out in your folder on the resent Impound Auction.

Item #5 Vehicles & Equipment – Michael Juica stated they needed a part for the emulsion machine approx. \$600, to get the part to heat up the emulsion. Motion made by Cody Barnett to purchase the part needed for the emulsion machine, seconded by Mayor Pro-Tem Vincent Babb. Motion carried unanimously.

Item # 6 Road Work – Mayor Pro-Tem stated we pretty much already talked about the road work, so we just will have no action on this.
