AN ORDINANCE

AN ORDINANCE CALLING AN ANNUAL ELECTION OF CITY OFFICIALS IN THE CITY OF PAYNE SPRINGS, TEXAS, SETTING DATE OF ELECTION, SETTING TIME FOR ABSENTEE BALLOTING, APPOINTING ELECTION JUDGE, ABSENTEE JUDGE, AND ALTERNATE JUDGES, SETTING TIME AND PLACE OF ELECTION AND SETTING TIME FOR FILING APPLICATION FOR NAME OF CANDIDATE TO BE PLACED ON THE BALLOT, AND THE STATUTORY FEE TO BE PAID.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PAYNE SPRINGS, TEXAS:

SECTION I. That an election be ordered in said City for the election of the Mayor, five (5) Aldermen, and a City Marshall, said election to be held on Saturday, April 6, 1974, same being the first Saturday in April, at the City Hall located in the Community Center Bldg. on Highway 90 in said City, between the hours of 8:00 A.M. and 7:00 P.M.

SECTION II. That absentee balloting shall be held in said election at the home of the City Secretary, Mrs. Mary Sorrell, in said City between the dates of March 18, 1974, and April 2, 1974, and the Absentee Judge shall be the City Secretary.

SECTION III. That the Election Judge for the Annual City Officials Election on A pril 6, 1974, shall be appointed by the City Council prior to the election, and the Alternate Election Judge shall be appointed by the City Council, and they shall have the right to appoint as many Clerks as they deem advisable and necessary.

SECTION IV. That anyone wishing to file an application to have their names placed on the ballot as a candidate for the office of Mayor, Alderman or City Marshall, must file an application with the City Secretary of the City of Payne Springs, Texas, not later than March 5, 1974, at 6:00 o'clock P.M., and each application must be accompanied by a filing fee of \$10.00 cash to nelp defray the costs of the election.

SECTION V. No "write in" votes will be counted in the City Elections in Payne Springs, Texas, and only those candidates whose names appear on the official ballot will be considered in counting the votes.

SECTION VI. It is further ordered that Notice of the Election shall be published by posting a copy of this Ordinance in three public places in said City at least sixty (60) days prior to the Election.

AN ORDINANCE CALLING AN ANNUAL ELECTION OF CITY OFFICIALS IN THE CITY OF PAYNE SPRINGS, TEXAS, SETTING DATE OF ELECTION, SETTING TIME FOR ABSENTEE BALLOTING, APPOINTING ELECTION JUDGE, ABSENTEE JUDGES, SETTING TIME AND PLACE OF ELECTION AND SETTING TIME FOR FILING APPLICATION FOR NAME OF CANDIDATE TO BE PLACED ON THE BALLOT, AND THE STATUTORY FEE TO BE PAID.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAYNE SPRINGS, TEXAS:

SECTION I. That an election be ordered in said City for the election of the Mayor, five (5) Aldermen, and a City Marshall, said election to be held on Saturday, April 6, 1974, same being the first Saturday in April, at the City Hall located in the Community Center Bldg. on Highway 90 in said City, between the hours of 8:00 A.M. and 7:00 P.M.

SECTION II. That absentee balloting shall be held in said election at the home of the City Secretary, Mrs. Mary Sorrell, in said City between the dates of March 18, 1974, and April 2, 1974, and the Absentee Judge shall be the City Secretary.

SECTION III. That the Election Judge for the Annual City Officials Election on A pril 6, 1974, shall be appointed by the City Council prior to the election, and the Alternate Election Judge shall be appointed by the City Council, and they shall have the right to appoint as many Clerks as they deem advisable and necessary.

SECTION IV. That anyone wishing to file an application to have their names placed on the ballot as a candidate for the office of Mayor, Alderman or City Marshall, must file an application with the City Secretary of the City of Payne Springs, Texas, not later than March 5, 1974, at 6:00 o'clock P.M., and each application must be accompanied by a filing fee of \$10.00 cash to nelp defray the costs of the election.

SECTION V. No "write in" votes will be counted in the City Elections in Payne Springs, Texas, and only those candidates whose names appear on the official ballot will be considered in counting the votes.

SECTION VI. It is further ordered that Notice of the Election shall be published by posting a copy of this Ordinance in three public places in said City at least sixty (60) days prior to the Election.
