AN ORDINANCE CALLING AN ANNUAL ELECTION OF CITY OFFICIALS IN THE CITY OF PAYNE SPRINGS, TEXAS: SETTING DATE OF ELECTION SETTING TIME FOR ABSENTEE BALLOTING: PROVIDING FOR APPOINTMEN OF ELECTION JUDGE, ABSENTEE JUDGE, AND ALTERNATE JUDGE: SETTING TIME AND PLACE OF ELECTION, AND SETTING TIME FOR FILING APPLICATIONFOR NAME OF CANDIDATE TO BE PLACED ON THE BALLOT:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PAYNE, SPRINGS, TEXAS:

SECTION 1. THAT AN ELECTION IS ORDERED IN SAID CITY FOR THE ELECTION OF THE MAYOR, TWO (2) ALDERMEN, SAID ELECTION TO BE HELD ON SATURDAY, MAY 7, 1994, SAME BEING FIRST SATURDAY IN MAY, AT THE CITY HALL LOCATED IN THE COMMUNITY CENTER BLDG. ON HIGHWAY 90 IN SIAD CITY, BETWEEN THE HOURS OF 7:00 A.M. AND 7:00 P.M.

SECTION 2. THAT EARLYING VOTING SHALL BE HEALD IN SIAD ELECTION AT THE HOME OF THE CITY SECRETARY MRS. L. BYRES IN SAID CITY BETWEEN THE DATES OF APRIL 18 ANDMAY 2 1994 AND EARLING VOTING JUDGE SHALL THE CITY SECERTARY.

SECTION 3. THAT THE ELECTION JUDGE FOR THE ANNUAL CITY OFFICIALS ELECTION ON MAY 7 1994, SHALL BE APPOINTED BY THE CITY COUNCIL PRIOR TO THE ELECTION, AND THE ALTERNATE ELECTION JUDGE SHALL BE APPOINTED BY THE CITY COUNCIL, AND THEY SHALL HAVE THE RIGHT TO APPOINT AS MANY CLERKS AS THEY DEEM ADVISABLE AND NECESSARY.

SECTION \$ THAT ANY ONE WISHING TO FILE AN APPLICATION TO HAVE THERE NAMES PLACED ON THE BALLOT AS A CANDIDATE FOR THE OFFICE OF MAYOR, ALDERMAN, MUSTFILE AN APPLICATION WITH THE CITY SECRETARY OF THE CITY OF PAYNE SPRINGS, TEX. NOT LATER THANMARCH 23, 1994 AT 5:00 O+CLOCK P.M. MMM

SECTION 5. NO "WRITE IN" VOTES WILL BE COUNTED IN THE CITY ELECTIONS IN PAYNE SPRINGS, TEXAS, AND ONLY THOSE CANDIDATES WHOSE NAMES APPEAR ON THE OFFICIAL BALLOT WILL BE CONSIDERED IN COUNTING THE VOTES.

SECTION 6. IT IS FURTHER ORDERED THAT NOTICE OF THE ELECTION SHALL BE PUBLISHED BY POSTING A COPY OF THIS ORDINANCE IN THREE $\frac{1}{4}3\frac{1}{4}$ PUBLIC PLACES IN SAID CITY AT LEAST SIXTY(60) DAYS PRIOR TO THE ELECTION.
